## Terms & Conditions

### Service Descriptions

**Home Care - Domestic** - work FOR the client which includes light domestic duties, e.g. cleaning (excludes heavy duty cleaning), laundry, meal preparation, shopping, running errands etc.

**Home Care - Personal standard** - Personal/Respite Care work completed FOR the client to assist them to maintain their independence. The client must assist with the completion of tasks. This can include assistance with activities of daily living, e.g. hygiene tasks, toileting, dressing, grooming, meal assistance, continence support, medication, exercise regimens, community access, social support, mobility assistance and transfers. Where required, includes clinical tasks, behaviour support, specialist management plans, customised equipment, reduced access to emergency services.

**Community Access** - work completed WITH the client to assist them to maintain their independence. The client must assist with the completion of tasks. This can include assistance with activities of daily living, e.g. exercise regimens, community access, social support, mobility assistance and transfers.

**Sleepover** - a ten (10) hour period of service for clients where the carer is expected to provide a total of three (3) active hours of care.

**Service establishment** - includes the administration of new referrals to AHC, assessment of patient needs within AHC service offering, identification and co-ordination of appropriate support workers, induction of staff to the patient's specific needs.

#### Good & Services Tax (GST)

GST applies to all services purchased by a third party organisation on behalf of a client. Private clients purchasing services directly pay GST on home based services, with the exception of personal care services which are generally exempt from GST.

#### Payment Terms

Payment in full within 14 days from date of invoice.

#### Minimum Shifts

A minimum 1 hour charge applies to all shifts.

#### Cancellations

Customer cancellations less than 24 hours before service commencement will incur the following charges:

- Between 4 - 24 hours prior to service commencement: The Base hourly rate will be charged
- Less than 4 hours prior to service commencement: Full price of rostered shift will be charged

At the sole discretion of AHC, this charge may be waived under certain circumstances.

#### Pricing

Pricing is effective from the date of this Schedule.

AHC updates its fees on an annual basis, either on the 1st of July or upon the contract anniversary date. In any event, AHC reserves the right to amend prices with one months' written notice.
